Mobility: Transportation, Proximity, Telecommunications

Commuting patterns: Where do people live and where are jobs and services that they are traveling to? What are our travel patterns?

## Equity:

Where are people in lower economic levels living and what is their proximity to major employment hubs and services? What is their proximity to transit? How many low income neighborhoods are missing high-priority sidewalks? What does it cost annually to own a car and what percentage of income is that?

- Housing = 28% of annual income
- Transportation = 20% of annual income (average transportation costs are just under \$12,000/year)


Housing +Transportation Affordability Index (Austin) - Per H+T Index:

	Avg. Annual Housing Cost as% of Income	Avg. Annual Transpo Costs as % of Income
Austin	28%	20% (\$12K/year)
Manor	27%	25% (\$15K/year)
Bastrop	21%	24% (\$14.3K/year) TRANSPO COSTS GREATER THAN HOUSING!
